A separate Google Classroom will be set up for the Floral Design CDE and this event will be done through Bloomy Pro.

#### G. National Ag Day

National Ag Day is March 23, 2021. Talia Priore will be attending the National Ag Day conference and meeting with legislators to advocate for agriculture.

#### H. Winter CDEs

Farm Business Management, Forestry, and Meat Evaluation and technology are the winter CDEs. The event will be held online March 23-25. Participant sign ups are due to the state by March 1.
