I. Opening Ceremonies

II. Minutes from July State Meeting

Motion by Julia Moreno to dispense with the reading of the meeting minutes and approve them as distributed.

III. Treasurer's Report

The opening balance for the month was \$140,825.40 and the closing balance was \$147,773.34

The board reviewed the proposed Association Budget.

Motion by Maisie Shimko to accept the 2023-2024 State FFA Association Budget. Seconded by Jonathan Finney. Motion passed.

Mr. Cruzan provided Mrs. Noble with a written report to share: July was a busy month for NJAAE. Our association hosted the Region VI Conference for the National Association of Agricultural Educators (NAAE) at Allentown High School. Attendees helped judge regional

awards, participated in committee work, and completed various agricultural tours. Tours included Holland Greenhouses, Rutgers Cream Ridge Research Center, Heritage Hill Farms, and Bullock Farms. 21 members from across the region attended. In addition, awards were announced from NAAE. We are pleased to announce Ms. Renee Stillwell has been selected for the Teacher Turn the Key Program, which is geared for new/beginning teachers.

- c. Meat Evaluation Maisie Shimko attended for NJ FFA. The first ever event held in person went very well. There were 13 students from 4 chapters. Congratulations to all and to the Salem Tech FFA Chapter for placing 1st. They will represent New Jersey at the National FFA Convention in November.

B. Check Point #1

Checkpoint was held July 17-20 at the Rutgers Ecocomplex. The State officers learned about conversation skills and workshop facilitation. Immediately following Check Point #1, the state officers received direct training on the Impact curriculum and started planning their workshops for LEAD.

C. State Officer Summit

State Officer Summit was held July 24-28 in Washington, DC. State Officers learned about the advocacy processes and how to be a better advocate. This event also started the delegate process for the National Convention. The team met State Officers from all over the country and conducted legislative visits.
